### Zambia-Japan and Uganda-Japan "Quality Infrastructure Dialogue"

Continuous Discussion for the Promotion of "Quality Infrastructure Investment"

The Ministry of Land, Infrastructure, Transport and Tourism held "Quality Infrastructure Dialogue" in Lusaka City, Republic of Zambia on April 11th, and in Kampala City, Republic of Uganda on April 5<sup>th</sup>. Based on the Memorandum of Understanding between State Minister Suematsu and cabinet member of infrastructure in January this year in High Quality Infrastructure Conference\*, "Quality Infrastructure Dialogues" were held to continue the relationships established through the conferences and follow-up activities.

Based on the achievement of "High Quality Infrastructure Conference" in January, Japanese infrastructure related companies made presentations on high quality infrastructure technologies and solutions which are expected to be applied in Zambia such as operation and maintenance technologies for roads and bridges, and urban transportation system. They also exchanged opinions.

We agreed to hold the 2<sup>nd</sup> "High Quality Infrastructure Conference" in this autumn in Zambia and establish four thematic study groups including "Roads and Bridges" and "Urban Transportation," which Zambia has high needs for infrastructure development.

(5) Summary

The Ministry of Works and Transport made presentations on their needs of capacity building in the fields of operation and maintenance measures for roads and bridges, and methods of traffic demand analysis. Japanese infrastructure related companies made presentations on high-quality infrastructure technologies and solutions which are expected to be applied in Uganda. They also exchanged opinions.

We agreed to consider holding the 2<sup>nd</sup> "Uganda-Japan Quality Infrastructure Dialogue" in Japan and establish thematic working groups including "Roads and Bridges" and "Transportation Management" which Uganda has high needs for infrastructure development.
